### **Coach / Bus Passenger's Luggage**

Each passenger may carry one small item of hand luggage onto the Coach.

In this context hand luggage means something that is capable of being stored in the overhead rack or beneath the seat and **NOT** on the seat beside you.

Hand luggage carried inside the Coach must not be placed where it could obstruct the passageway or any passenger entrance or emergency exit but must be placed under a seat or in an overhead rack as appropriate.

Any additional luggage may only be carried by placing it in the designated Coach luggage compartment.

All luggage must be securely packed, fastened and locked before being placed in or taken on vehicles. All luggage must also be clearly labelled with the name, address of the accompanying passenger.

Passengers are required to place an ID label on each item of luggage placed in the luggage compartment of the vehicle and will be required to produce evidence of identity to a JJ Kavanagh & Sons Driver or other authorised official on request.

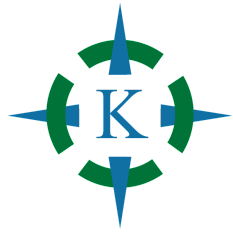
All items of passengers' luggage as described in the foregoing are carried by JJ Kavanagh & Sons at owner's risk, irrespective of whether or not they have been handed to a JJ Kavanagh & Sons employee and without regard to the part of the vehicle in which they are carried or by whom they have been so placed in such Coach.

JJ Kavanagh & Sons, its employees, agents, and/or subcontractors shall not be liable for loss of and/or damage to passengers' luggage or any passengers' personal possessions, unless such loss or damage is proven to have been caused by the negligence, breach of duty or breach of statutory duty of JJ Kavanagh & Sons, its employees, agents or subcontractors.

Personal effects or items of luggage of a relatively expensive nature should not be packed in luggage placed in the luggage compartment, but should be kept in a passenger's hand luggage or on the person of that passenger. JJ Kavanagh & Sons will not be liable for any loss of or damage to such articles if placed in the luggage compartment.

JJ Kavanagh & Sons will not be liable for financial loss involving cash, currency, cheques, credit/cash/charge cards, or for loss of travel or identity documents of any kind.

JJ Kavanagh & Sons will not accept any claim for loss of or damage to property from a third party or made by a passenger on behalf of a third party, irrespective of whether a passenger's luggage contains items belonging to any such third party.

Any claim in respect of loss of or damage to property must be made to JJ Kavanagh & Sons within 24 hours of the journey on which the loss or damage is alleged to have occurred. A full written report detailing such loss or damage must be submitted within five days of that date to the relevant office in JJ Kavanagh & Sons which deals with such matters as notified from time to time.

The foregoing Conditions of Carriage of Passengers' Luggage are applicable on JJ Kavanagh & Sons services within Ireland.

Customers are asked not to bring food or drink on board which would present a risk to the safety, cleanliness and condition of our vehicles or the comfort of fellow passengers and to avoid bringing hot or strong-smelling food on board. Any food and drink brought on board must be in an appropriately sealed or fastened container to avoid any risk of spillage and any rubbish must be taken when leaving the Coach

- The consumption of alcoholic drinks is not permitted on the Coach.
- Smoking on the Coach is strictly prohibited.
- CCTV is in operation on the Coach for Passenger's Safety and Comfort
